

Personal Statement

Andy Sphicas

I started working as an Engineer with J & P (O) Ltd in 1977 and in the years to come, I worked my way up the hierarchy of the company, which is considered one of the top 40 construction companies in the world. In 1991 – 1992, I was General Manager of Wade Adams in Botswana, between 2002 – 2005 I was Technical Manager of A. PANAYIDES CONTRACTING PUBLIC LTD and since the beginning of 2006 I am a Consultant on Construction Contracts and I undertake project management and financial evaluation.

Through my work as Project Engineer, Senior Project Engineer, Project Manager and Senior Project Manager with large companies, on large and complex projects of diverse nature, for big clients and leading consultants, in multi-cultural societies and diversified environments, I have gained valuable experience in and knowledge of the construction work, the construction business and the construction world in general.

As a Project Engineer at the beginning of my career, I followed the day to day planning of work, allocated project resources to daily tasks, controlled the output of both teams of people and equipment and implemented drawings. Furthermore, I directed the foremen, supervised the work and liaised with the Inspection Engineer.

Projects for which I was Project Engineer with J & P (O) Ltd included the construction of nine blocks of flats (US\$26 million) and a group of minor projects (US\$7,5 million) in Abu Dhabi and the Al Ain area, both for the Abu Dhabi National Oils Company (ADNOC). The latter included sports complexes (Ramada Hotel Abu Dhabi), swimming pools, the Tawan Hospital Al Ain, a restaurant, a club, a clinic, a bank's premises at the Umm al Nar Housing Complex, as well as prestigious villas for H. E. the Minister of Public Works and Housing.

In 1980, I was Senior Project Engineer for the project of constructing the Armed Forces Headquarters in Abu Dhabi, together with all amenities necessary for the provision of the required services, a contract amounting to US\$55 million.

Between 1982 - 1985, I was employed by Dar El Emara and became Project Director for the Al Shark Development on Das Island, a group of projects of US\$135 of the Abu Dhabi Marine Operating Company (ADMA-OPCO). It involved the construction of a new township (buildings, roads and services) on the Island, with all necessary infrastructure (provision of new services, relocation and removal of existing services including bunker lines, gas lines, H.V., L.V., potable, waste, saline water and drainage) and superstructure (accommodation blocks, kitchens, restaurants, cinema and other amenities). The projects, undertaken by many different contractors, also included many five-storey accommodation blocks with the highest of specifications, including external GRC and marble cladding. Co-ordination of all contractors so as to meet the extremely high technical and safety standards required on an oilfield area with ongoing oil extraction, as well as the restrictions as regards the number of people working on the projects and for oil extraction at all times, made the whole venture a most difficult and yet challenging one. Directing the said group of projects also entailed liaising with the Design Office in London and Beirut.

At the same time and in addition to the project on Das Island, I was Resident Engineer for the private housing projects (US\$27,5) for H.E. the Minister of Petroleum of the United Arab Emirates, as well as Resident Engineer for various projects in Abu Dhabi and Das Island.

As Project Manager with J & P (O) Ltd, between 1985 - 1991, I undertook projects such as the sewerage, stormwater and land drain project of Al Rashidiya East (US\$ 8,5 million), the construction of official offices for the Sheikh of Ajman (US\$30 million) and the improvement of intersections and widening of main roads in Abu Dhabi (US\$22,75 million).

Between 1992 - 1994 I was again Project Manager for two J & P (O) Ltd projects of US\$81,7 million. These involved the construction of 8km of an 8-lane expressway including two interchanges and 12km of an 8-lane expressway again with two interchanges. The said projects required implementation of sophisticated computer-aided methods for planning, with a very rigorous implementation of critical path analysis for the co-ordination of all resources and follow-up, so as to ensure completion of work within 24 months. They also involved creating and running one of only three material checking laboratories in the U.A.E. with ISO 9000 approval, which was also directly my responsibility.

As a Project Manager/ Director, my work involved being responsible for the overall planning of work to be executed, the procurement of materials and devising the best technical construction methods. Optimisation of the allocation and use of resources, following up of the costing process and liaison with all the departments involved in the project, planning, administration, storekeeping, as well as human-resource management were also amongst my duties. In addition, I prepared claims, evaluated alterations and modifications and co-operated closely with the Consulting Engineers as well as the Client's Engineers.

Once promoted to Senior Project Manager, between 1995 - 1997, and whilst still with J & P (O) Ltd, I was in charge of the Jumeirah & Al Safa sewerage and drainage project (US\$11,5 million), the asphalt rehabilitation works in the Dubai - Abu Dhabi Road Highway (US\$2,5 million) and the road works in the Jebel Ali Freezone area (US\$1,5 million). As a Senior Project Manager, I supervised the work of all Project Managers reporting to me.

My experience, however, spans from engineering and construction to planning and costing as well as structural design. More specifically, in 1981 and 1982, I was Head of the Planning and Costing Department of J & P (Oman) LLC in Oman. This involved my being in charge of the pre- and post-tender follow-up of contracts with particular responsibility on planning, co-ordination and allocation of all resources (labour, plant and materials), thus ensuring the timely and

within-budget execution of contacts. In addition, as from 1982 and up until 1985, I was Head of the Structural Design and Computer Department of Dar El Emara. As Project Director for the Al Shark Development on Das Island, I also carried out feasibility studies as regards the individual projects of the whole venture.

Furthermore, as the General Manager of Wade Adams in Botswana between 1991 – 1992, my work involved co-ordination of Managers of the Wade Adams corporation in other African countries. Seeing to the optimisation of resource usage for the corporation in its different places of business and dealing with the financial aspects of running the corporation were also amongst my duties. In Botswana alone, projects involved the construction of housing and army installations of a total value of US\$50 million.

Between 1997 – 2001 I was based in Cyprus as Project Manager for the New Nicosia General Hospital, a project of CHAPO-APC JV. Between 2002 – 2005, I was Technical Manager of A. PANAYIDES CONTRACTING PUBLIC LTD.

Since the beginning of 2006 I am a Consultant on Construction Contracts (assistance to contractors on programming, technical matters, preparing and negotiating time and financial claims etc), I undertake project management for large projects, I undertake the evaluation of time and financial claims for large employers etc.

I participate actively in the Disciplinary Committee of the Technical Chamber of Cyprus and in the work of the Chamber in general and I am also a member of the Committee of the Cyprus Branch of the Chartered Institute of Arbitrators.

Other activities include presentation of the topic of "Introduction to Arbitration" in a seminar on "Contracts and Arbitration" organised by the Cyprus Association of Civil Engineers and publishing two articles in the weekly publication of the Technical Chamber of Greece on "The optimisation process in construction" and "Method of design of slender columns of any shape, reinforcement and loading conditions".

Since 2001 I have been a lecturer in training programs on Dispute Resolution and Arbitration, Programming Construction Works, Project Management, Claims for Time, Direct Loss and/ or Expenses, Project Estimating and Tendering, Contract Law, Effective Letter-writing in Construction etc, all of which are approved by the Human Resource Development Authority of the Ministry of Labour and Social Insurance of Cyprus.

So far I have also been appointed as arbitrator in about 70 disputes between Employers and Contractors, Contractors and Sub-Contractors and Employers and Consultants.

In addition, having succeeded in the examination of the Ministry of Commerce, Industry and Tourism, I have been authorized, since April 2011, to act as an expert in energy saving in buildings used as dwellings.

Finally, having completed the Mediation Accreditation Assessment of the Chartered Institute of Arbitrators in 2011, I have since been a CIArb Accredited Mediator.
